Approval of Adoption of the Illinois Plumbing Code

Pursuant to Section 36 of the Illinois Plumbing License Law (the "Law"; 225 ILCS 320/36) and Section 750.800(b) of the Illinois Plumbers Licensing Code (the "Code"; 68 Il. Adm. Code 750.800(b)), units of local government should seek Illinois Department of Public Health ("IDPH") advisement and approval to administer a plumbing program. The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Town of Cicero based upon the governmental unit's adoption of the Illinois Plumbing Code (77 Il. Adm. Code 890) in its current form.

Chapter 22. Article II. – Plumbing Code – Sec. 22-31 Adopted

The Town hereby adopts, by reference as if full set forth in this Code, the Illinois Plumbing Code...as published at Title 77, Part 890 of the Illinois Administrative Code. The Illinois Plumbing Code governs the design and installation of new plumbing or plumbing systems and the alteration of plumbing systems."

Pursuant to 17 III. Admin. Code 3730.307(c)(4) and subject to the Illinois Plumbing Code (77 III. Admin. Code 892), all new plumbing fixtures and irrigation controllers installed after the effective date of this ordinance shall bear the WaterSense label (as designated by the U.S. Environmental Protection Agency WaterSense Program), when such labeled fixtures are available.	9-24-15	9-24-18
