To determine the liquid holding capacity of the connected fixture(s), the fixture basin length is multiplied by the width then by the height, in inches, then divided by 231, then divided by a 1 minute drain time. When two or more sinks or receptacles are connected to an interceptor the liquid-holding capacity shall be based on the combined volume of all the fixtures served as calculated above in addition to the flow rate of other fixture types as established by the fixture manufacturer or by calculation of drainage fixture units similar to Section 890.1330 b) multiplied by a one minute drain time. For the purpose of sizing a hydro mechanical grease interceptor the resulting units are taken as gallons per minute, and for the purpose of sizing a gravity grease interceptor, as gallons. ii) This code shall not prohibit the installation of two grease interceptors installed in a parallel system as long as each interceptor is properly sized as required in Section 890.510 a)2)i) for the connected fixture holding capacity.</i></p>	05-15-17	05-15-20
