Approval of Adoption of the Illinois Plumbing Code

Pursuant to Section 36 of the Illinois Plumbing License Law (the "Law"; 225 ILCS 320/36) and Section 750.800(b) of the Illinois Plumbers Licensing Code (the "Code"; 68 Il. Adm. Code 750.800(b)), units of local government should seek Illinois Department of Public Health ("IDPH") advisement and approval to administer a plumbing program. The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Village of Elmwood Park based upon the governmental unit's adoption of the Illinois Plumbing Code (77 Il. Adm. Code 890) in its current form.

Chapter 37 "Plumbing Code", Section 37-1 "Adoption of Plumbing Code"

"The current edition of the Illinois State Plumbing Code (77 Ill. Admin. Code, Part 890) promulgated by the Illinois Department of Public Health is hereby adopted as the Plumbing Code of the Village of Elmwood Park, to establish regulations for the minimum control of plumbing materials and fixtures, and for the design, construction and installation of plumbing systems in the Village, and each and all of the regulations, provisions, conditions, and terms of the Illinois State Plumbing Code...are hereby referred to, adopted and made a part of hereof..."
