**Approval of Adoption of the Illinois Plumbing Code**

Pursuant to Section 36 of the Illinois Plumbing License Law (the “Law”; 225 ILCS 320/36) and Section 750.800(b) of the Illinois Plumbers Licensing Code (the “Code”; 68 Il. Adm. Code 750.800(b)), units of local government should seek Illinois Department of Public Health (“IDPH”) advisement and approval to administer a plumbing program. The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Village of Lake Villa based upon the governmental unit’s adoption of the Illinois Plumbing Code (77 Il. Adm. Code 890) in its current form.

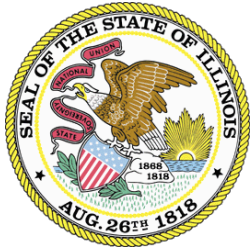

## APPROVAL OF PLUMBING ORDINANCE

Pursuant to Section 36 of the Illinois Plumbing License Law (the “Law”; 225 ILCS 320/36) and Section 750.800(b) of the Illinois Plumbers Licensing Code (the “Code”; 68 Il. Adm. Code 750.800(b)), the Illinois Department of Public Health is authorized to review and approve proposed ordinances of governmental units related to the design of plumbing materials, and the operation and maintenance of plumbing systems. The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Village of Lake Villa based upon IDPH’s review and analysis of (i) the proposed ordinance, and (ii) the applicable information, facts and circumstances pertaining to this review presented by the governmental unit.

Ordinance Number 0915-847-0041  Pursuant to 17 Ill. Admin. Code 3730.307 (c)(4) and subject to the Illinois Plumbing Code (77 Ill. Adm. Code 890) and the Lawn Irrigation Contractor and Lawn Sprinkler System Registration Code (77 Ill. Adm. Code 892), it is hereby ordained that in the Village of Lake Villa, all new and replacement plumbing fixtures and irrigation controllers installed after the effective date of this ordinance shall bear the WaterSense label (as designated by the U.S. Environmental Protection Agency WaterSense Program), when such labeled fixtures are available.	9-21-15	9-21-18
