Approval of Adoption of the Illinois Plumbing Code

Pursuant to Section 36 of the Illinois Plumbing License Law (the "Law"; 225 ILCS 320/36) and Section 750.800(b) of the Illinois Plumbers Licensing Code (the "Code"; 68 Il. Adm. Code 750.800(b)), units of local government should seek Illinois Department of Public Health ("IDPH") advisement and approval to administer a plumbing program. The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Village of Forest View based upon the governmental unit's adoption of the Illinois Plumbing Code (77 Il. Adm. Code 890) in its current form.

The Illinois Plumbing Code, 77 Ill. Admin. Code 890 et seq., as amended from time to time, is hereby adopted by reference in its current form for the purpose of establishing rules and regulations for the materials, construction, alteration, and inspection of plumbing placed in or in connection with any building within the Village of Forest View.

The review and approval of the following governmental unit ordinance applies solely to the authorized governmental unit for the Village of Forest View based upon IDPH's review and analysis of (i) the proposed ordinance, and (ii) the applicable information, facts and circumstances pertaining to this review presented by the governmental unit.

Pursuant to 17 Ill. Admin. Code 3730.307 (c)(4) and subject to the Illinois Plumbing Code (77 Ill. Admin. Code 890) and the Lawn Irrigation Contractor and Lawn Sprinkler System Registration Code (77 Ill. Admin. Code 892), all new plumbing fixtures and irrigation controllers installed after the effective date of this ordinance shall bear the WaterSense label (as designed by the U.S. Environmental Protection Agency WaterSense Program), when such labeled fixtures are available.	9-2-15	9-2-18
